Street Program –

• Interlocal Agreement -

New Business:

• \$50,000 allocation to the Point Return Grant -

Marty Nickels made the motion, seconded by Phil Friese to allocate \$50,000 from the General Fund to the Parks Fund which will be dedicated to the Point Return 50/50 Grant. Motion passed unanimously.

• Disposal Resolution -

A resolution was read to dispose of various Fire Department radios via donation or sale. Phil Friese made the motion, seconded by Hank Hudson. The motion passed unanimously. This is now **Resolution#2016-R-04**.

• Park Usage Fees Resolution -

After brief discussion regarding the waiving of fees for employees and city officials, it was agreed upon by council that the waiving of the fees would only apply to the employees. The conversation continued with changes to the resolution's pricing and verbiage. After changes were made, the council agreed to accept the written changes and read the resolution. Hank Hudson made the motion, seconded by Phil Friese. The motion passed unanimously. This is now **Resolution# 2016-R-05**.

After the reading of the resolution, Marty Nickels made the suggestion that more of our police officers should have keys to access the pay boxes. He also suggested that we get new types of money carriers.
