

# AN ORDINANCE AMENDING ORDINANCE 2008-06 BUILDING AND PLUMBING FEES TO INCLUDE FEES CHARGED FOR MATTERS BROUGHT BEFORE THE BULL SHOALS, ARKANSAS PLANNING COMMISSION AND THE BULL SHOALS, ARKANSAS BOARD OF ZONING ADJUSTMENT

# REPEALING ORDINANCE 2008-06, SESQUINCENTENNIAL PLANNING AND ZONING PERMIT FEES

WHEREAS the fees for matters brought before the Planning Commission of Bull Shoals have not been updated since April 24th, 2008, and

WHEREAS the fees for these matters were formerly included in an ordinance setting building and plumbing fees with a 5% increase per year since 2009, and

WHEREAS there is a need to amend Ordinance 2008-06,

BE IT ORDAINED BY THE CITY COUNCIL OF BULL SHOALS, ARKANSAS

Section 1 Ordinance 164 is hereby repealed.

Section 2. Ordinance 2006-4 is hereby repealed.

Any project requiring a change on the City maps shall Include a map change fee of \$250 00 or actual cost, whichever is greater.

Any project requiring publication of public notice shall Include a publication fee of \$150,00, or actual cost, whichever is greater (Ord. No 2025-04, Sec.3)

#### **Section 4 Automatic Increases of Fees**

All permit fees shall Increase 2% per year or whatever the CPI rate is according to Federal publication, whichever is greater beginning in 2026. This amount shall be rounded up to the next higher dollar amount, except for the per square foot charge for residential and commercial building permits and per circuit charge on electrical permits which shall be rounded to the next higher cents.

## Section 5 Distribution of fees beginning in 2025.

The Building Inspector/Official shall receive 50% of permit fees for new residential building permits and additions, 50% of new commercial construction permits and 60% of permit fees collected for other permits within his/her jurisdiction.

The plumbing inspector or his/her designated representative shall receive 50% of permit fees except water and sewer tap fees.

Any person, firm, corporation, or other identity found violating any of the provisions of this ordinance shall be subject to a fine, not less than \$200 00, not more than \$1,000 00 for each day for which a violation continues to exist.

#### **Section 6. SEVERABILITY**

The provisions of this ordinance are hereby declared to be severable. If any part of this ordinance is declared unconstitutional or invalid for any reason, such declaration shall not be held to invalidate or impair the validity, force, or effect of any other part of the ordinance.

### **Section 7 Emergency Clause**

That this Ordinance being necessary to continue operation of the City of Bull Shoals in compliance with the laws of the State of Arkansas and to preserve the public peace, health and safety, an emergency is hereby declared and this Ordinance shall be in full force and effect upon the date of its passage and approval.
