

ORDINANCE 2018-02

AN ORDINANCE TO REPEAL AND REPLACE ORDINANCE 2003-15 ESTABLISHING FEES AND PENALTIES FOR THE USE OF CITY OF BULL SHOALS PARK FACILITIES, AND ALSO REPEALING RESOLUTIONS 2001-R-07, 2017-R-04, and 2017-R-05; AND FOR OTHER RELATED PURPOSES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BULL SHOALS:

Section 1. That the fees for the City of Bull Shoals Parks Facilities are as follows:

Pavilions \$35.00 for 1/2 day (8 AM - 3 PM or 3 PM - 10 PM)
 \$50.00 for full day (8 AM - 10 PM)

Meeting Place \$35.00 for 1/2 day (8 AM - 3 PM or 3 PM - 10 PM)
 \$50.00 for full day (8 AM - 10 PM)
 \$ 7.50 for 1/2 day (\$15.00 for full day) by a non-profit organization

Campsites (Define a day as 1:00 PM to 11 AM the Following Day)

In each campground, there is a limit of 21 days per stay (see park policies).

Point Return Park:

These sites are for pop-up campers and tent camping only. No more than one (1) pop-up camper and two (2) tents per site or three (3) tents maximum per site. RV's are limited to Dam Site RV Park only. There is no Maximum stay (see park policies).

\$12.00 per day

Dam Site Park:

Site No. 2 with septic hook-up shall be \$35.00 per day.

50 amp sites shall be \$25.00 per day

30 amp sites shall be \$20.00 per day

Boat Launch Pass \$5.00 per day per boat or

\$50.00 annually (\$25.00 with National Parks and Federal Lands Pass - Formerly Golden Age Passport) See Penalties, Sec. 2, of this document.

Other Park \$15.00 for 1/2 day (8 AM - 3 PM or 3 PM - 10 PM)

Facilities \$30.00 for full day (8 AM - 10 PM)

All Park Facilities Free of charge (including boat launch) to City of Bull Shoals employees and for official City of Bull Shoals related functions.

Discounts: A discount of 10% may apply to Seniors (65 and older) as well as to active or retired military with valid Military Identification. The discount shall apply Sunday through Wednesday, only one discount may be used.

Cancellation Fee The City of Bull Shoals reserves the right to charge a \$15.00 fee per individual if a reservation is cancelled within 14 days.

Section 2. Penalties - Individuals not adhering to the guidelines of this Ordinance or any other Resolution or Ordinance concerning use of the City of Bull Shoals Park Facilities will be fined a maximum of \$50.00 per day, per incident. Second offence fines may be raised to \$75.00. For first offense Launch infractions, purchase a City of Bull Shoals Launch Permit may substitute for fine.


Section 3. Ordinance 2003-15, and Resolutions 2001-R-07, 2017-R-04 and 2017-R-05 are hereby repealed.

Section 4. If any part of this Ordinance is declared invalid or unconstitutional for any reason, such declaration shall not be held to invalidate or impair the validity, force or effect of any other part of this Ordinance.

Section 5. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Section 6. This ordinance shall be in full force and effect from and after its passage.
