

RESOLUTION NO. 2016-R- 05

A RESOLUTION BY THE MUNICIPAL GOVERNING BODY OF BULL SHOALS, ARKANSAS TO ESTABLISH FEES AND USAGE FOR THE CITY OF BULL SHOALS PARKS SYSTEM.

WHEREAS: In the City Code 12.04.06 Fees. It states, "Fees for parks shall be established by Resolution".

Therefore; be it Resolved by the City Council of Bull Shoals, Arkansas that
The Fees for the City of Bull Shoals Parks and Facilities are as follows:

Danuser Park;

Campsites

A Campsite day is a 22-hour period beginning 1 PM one day to 11 AM the following day. These sites are restricted to Pop-up, Self Contained Campers and tent camping. RV's will be referred to Dam Site RV Park. Up to three tents or one, pop-up or self-contained camper, and two tents per site. Fee \$10.00 per day. With a 21-day maximum stay period.

Boat Launch at Browns Beach,

This is a City of Bull Shoals Boat Launch. Corps of Engineers pass is not applicable.

\$5.00 per day per boat or
\$50.00 annually (\$25.00 with Golden Age Passport)

Dam Site RV Park

A Campsite day is a 22-hour period beginning 1 PM one day to 11 AM the following day. RV Sites are for One RV per site with up to two additional tents. Fees \$25.00 per day for the 50 Amp service and \$20.00 per day for a 30 Amp service. With a 21-day maximum stay period.

The Park facilities at Point Return, Browns Beach, and Danuser Park are Free of Charge to City of Bull Shoals Employees and for Official Functions of The City of Bull Shoals.

The Park facilities at Dam Site Park are half price to City of Bull Shoals Employees. (Not applicable on holiday time periods.)

Cancellation Fees;

The City of Bull Shoals reserves the right to charge a \$15.00 fee if a reservation is cancelled with in a seven-day period.

Penalties

Individuals not adhering to the guidelines of this Resolution or any Resolutions or Ordinances concerning the use, rules and Fees of the City of Bull Shoals Park System could be fined a maximum of Fifty Dollars (\$50.00) per day, per incident. Enforcement of these Ordinances and Resolutions shall be the duties of the Bull Shoals Police Department.

This Resolution is to take effect immediately upon passage by the City Council of Bull Shoals, Arkansas.
