NOW THEREFORE, BE IT RESOLVED THAT, WE THE ELECTED OFFICIALS of the City of Bull Shoals do hereby adopt the Arkansas Association of Chief's of Police Model Policy Project and further authorize the Chief of the Bull Shoals Police Department to, from time to time, update the Policies within the Bull Shoals Police Department to remain consistent with the A.A.C.O.P.'s most current and updated model policies, to efficiently and effectively run and operate the City of Bull Shoals Police Department.
