

RESOLUTION NO. # 2023-R- 03

A RESOLUTION BY THE MUNICIPAL GOVERNING BODY TO AMEND THE 2022 CITY BUDGET FOR THE CITY OF BULL SHOALS, ARKANSAS

PROVIDEING FOR AND APPROPRIATING MONEY FOR EACH AND EVERY
ITEM OF EXPENDITURE FOR THE TWELVE (12) MONTHS BEGINNING JANUARY 1,
2022, AND ENDING DECEMBER 31, 2022

WHEREAS, The City of Bull Shoals, Marion County, Arkansas, has previously reviewed and adopted a budget resolution accepting the attached Budget for the twelve (12) month period beginning January 1, 2022, and ending December 31, 2022, and,

WHEREAS, The City Council of the City of Bull Shoals has authorized additional expenditures during the period beginning January 1, 2022, and ending December 31, 2022.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF BULL SHOALS,
ARKANSAS:

Section 1. This resolution shall be known as the Budget Reconciliation Resolution for the City of Bull Shoals, Arkansas for the twelve (12) month period beginning January 1, 2022, and ending December 31, 2022.

Section 2. Annual Budget Adopted by Reference

The Annual Budget for calendar year 2022, identified as “2022 Annual Budget, Bull Shoals, Arkansas” is hereby adopted by reference. A copy of the said budget shall be filed in the office of the City Clerk and shall be available for inspection and copying by any person during the normal working hours.

Section 3. Said budget shall also take note and authorize the expenditure of additional funds, prior approval of which has been duly set forth and directed in approved Minutes for the Months of March, June, and September 2022 by the City Council of Bull Shoals, Arkansas:

- 1) Through a Roll Call Vote, 6 Ayes and 0 Nays, Resolution 2022-01 authorizing the purchase of one Patrol Vehicle for the City of Bull Shoals Police Department in the FY’2022 Budget. It is a 2022 Ford Police Interceptor Utility AWD patrol vehicle and shall not exceed \$37, 000.
- 2) Through a Roll Call Vote, 4 Ayes and 0 Nays, Resolution 2022-02 authorizing the purchase of one Used F-450 Crew Cab Truck for the City of Bull Shoals Public Works Department in the FY’2022 Budget, shall not exceed \$33,250.00.
- 3) Through a Roll Call Vote, 5 Ayes and 0 Nays, Resolution 2022-03 authorizing the purchase of one New 2022 Ram 3500 Chassis Cab Truck for the City of Bull Shoals Public Works Department in the FY’2022 Budget, shall not exceed \$61,000.00.
- 4) Through a Roll Call Vote, 5 Ayes and 0 Nays, Resolution 2022-04 authorizing the purchase of one Crysteel E-Tipper Dump Body and Hoist to be instanlled on the City’s 2022 Ram 3500 Chassis Cab truck for the City of Bull Shoals Public Works Department in the FY’2022 Budget, shall not exceed \$16,500.00.

- 5) Through a Roll Call Vote, 6 Ayes and 0 Nays, Resolution 2022-05 authorizing the purchase of one Used F-450 Crew Cab Truck for the City of Bull Shoals Public Works Department in the FY'2022 Budget, shall not exceed \$33,950.00. This resolution corrects, amends, and supersedes the provisions of Resolution 2022-02
- 6) Through a Roll Call Vote, 6 Ayes and 0 Nays, Resolution 2022-08 authorizing the purchase of one Kawasaki SX XC Mule for the City of Bull Shoals Public Works Department in the FY'2022 Budget, shall not exceed \$11,000.00.
- 7) Resolution 2022-09 authorizing and approving funding to retain building hazard inspection services located at 928 Central Avenue shall not exceed \$15,000.00.
- 8) Through a Roll Call Vote, 6 Ayes and 0 Nays, Resolution 2022-10 modifies Resolution 2022-R-1 authorizing the purchase of one new 2023 Ram 1500 Chassis Cab Truck, or one new 2023 Dodge Durango Pursuit AWD at a cost not to exceed \$38,000.

Section 4. The respective amounts of funds for each item of expenditure classification herein documented by this Resolution and expended budget for 2022 are hereby approved by the City of Bull Shoals, Arkansas, and are hereby authorized and appropriated for the purposes herein set forth for the calendar year ending December 31, 2022.


