

RESOLUTION NO 2025-R-05

A RESOLUTION BY THE MUNICIPAL GOVERNING BODY OF BULL SHOALS, ARKANSAS TO ESTABLISH FEES AND USAGE FOR THE CITY OF BULL SHOALS PARKS SYSTEM

WHEREAS In the City Ordinance 2023-05, It states, "Fees for parks shall be established by Resolution."

Therefore, be it Resolved by the City Council of Bull Shoals, Arkansas that.

The Fees for the City of Bull Shoals Parks and Facilities are as follows.

Danuser Park; No Tents or RVs are allowed.

Pavilions \$35.00 for Half day (8 am-3 pm or 3 pm-10 pm)
 \$50 00 for Full day (8 am-10 pm)

Browns Beach. No tents or RVs are allowed.

Pavilions \$35 00 for Half day (8 am-3 pm or 3 pm-10 pm)
 \$50 00 for Full day (8 am-10 pm)

Campsites at Point Return

A Campsite Day begins at 1 pm one day to 11 am the following day These sites are restricted to Pop-up, and tent camping only **RV 's will be referred to Dam Site RV Park.** Up to three tents or one, pop-up and two tents per site. Fee \$15 00 per day With a 21-day maximum stay period. **NO GENERATORS ARE ALLOWED**

Boat Launch at Browns Beach,

This is a City of Bull Shoals Boat Launch. Corps of Engineers or State boat launch pass is not applicable.

\$ 5 00 per day per boat or

\$50 00 annually (\$25.00 with Golden Age Passport)

The Park facilities at Point Return, Browns Beach, and Danuser Park are Free of Charge to City of Bull Shoals Officials, Employees and for Official Functions of the City of Bull Shoals but **must be reserved.**

Dam Site RV Park.

A Campsite Day begins at 1 pm one day to 11 am the following day RV Sites are for One RV per site with up to two additional tents.

Site No. 1 Camp Host if applicable, otherwise same as site #2.

Site No 2 \$45 00/ day + Tax

50 Amp site: \$40 00/ day + Tax

30 Amp site: \$35 00/ day + Tax

A discount of 10% may apply to Seniors (65 and older) as well as to Veterans, and the Disabled with a valid Military identification or a disabled placard and must be displayed upon request or presented by customer to receive discount. (Only One type of discount per customer)

The Park facilities at Dam Site Park are half-price for City of Bull Shoals Officials and Employees. (Not applicable during holiday time periods.)

Cancellation Fees.

The City of Bull Shoals reserves the right to charge a \$15 00 fee if a reservation is cancelled within a seven-day period.

Penalties


As described in City Ordinance 2023-05, penalties shall apply as follows.

"Person in violation of this Ordinance or any other Resolution or Ordinance concerning use of the City of Bull Shoals Park Facilities will be fined a maximum of Fifty Dollars (\$50 00) per day, per incident. For the first offence Launch Infractions, purchase of a Bull Shoals Launch Permit may substitute for a fine. Second offence fines may be raised to Seventy-Five Dollars (\$75 00) per day, per incident. Enforcement of these Ordinances and Resolutions shall be the duties of the Bull Shoals Police Department."

This Resolution is to take effect immediately upon passage by the City Council of Bull Shoals, Arkansas.
